



## Camp Nehemiah Financial Agreement

Camp Nehemiah is a not-for-profit mission of Grace Community Christian Church. We strive to provide the very best care and education for your child at competitive rates. The following is a description of our financial policy:

### Registration Fees

A non-refundable registration fee is due at the time of enrollment to reserve a space for the weeks your child is registered to attend Camp Nehemiah. This year, Camp Nehemiah will operate June 6<sup>th</sup> through July 1<sup>st</sup>. **We will be closed the week of July 4<sup>th</sup>.** We will re-open starting the week of July 11, 2011.

### T-Shirts

One Camp Nehemiah t-shirt is provided with your child's registration fee, if your child's registration fee is received prior to our **Early Registration Deadline of May 15, 2011**. Camp T-shirt is required for every field trip and there will **NOT** be additional t-shirts for purchase.

### Tuition

Weekly tuition is \$135 per child and is due Friday for the following week. Please make checks payable to **Camp Nehemiah**. If your child is signed up and he/she cannot attend a particular week, **the full tuition cost of \$135 will be charge if a two week notice is NOT received.** Families with more than one camper will receive a discounted rate of \$125 for each additional camper.

### Credit Card on File

If weekly tuition is not received by the end of business day Monday, your credit card on file will be charged for the full week of tuition. If your credit card is declined, your child will not be able to attend camp unless **CASH** payment is received prior to admission into camp.

### Late Pick-Up Arrangements and Fees

Our goal is to care for the children participating in Camp Nehemiah in the best possible way. Children become anxious when it is time to go home and no one has come for them. It is not only unfair to the child, but to the staff who cannot complete their day-end duties to leave on schedule. For these reasons, we have made available to you at an additional cost and will be assessed as follows:

# of Days per week	Time Picked Up	Late Pick-up Fee
1 – 3 days	6:00 – 6:30pm	\$5.00 per day/per child – paid at time of pick-up
4 <sup>th</sup> and 5 <sup>th</sup> day	6:00 – 6:30 pm	\$5.00 per day/per child ( cannot apply \$15 wkly rate)
Weekly	6:00 – 6:30 pm	\$15.00 per child/per week (pd with tuition)

### Returned Checks

Any check returned from the bank marked Non-sufficient Funds (NSF) will result in a \$20 charge per check. If three returned checks occur, Camp Nehemiah will only accept payments by cash or cashier's check.
